

# NEVADA FFA ASSOCIATION STATE LEADERSHIP CAMP

## Rules for Participants and Release Form



In order to maintain an orderly leadership camp, to achieve the greatest amount of work, and for the health and safety of all participating FFA members, the following rules listed below must be read and signed by the participating member. The member must submit his/her signed copy of the rules upon arrival at camp.

### Rules of Nevada FFA Leadership Camp

- I will respect the authority of advisors in charge of FFA activities and cabins.
- I will attend every session and be in my assigned position prior to starting time.
- I will not do anything detrimental to the health and safety of other members and will respect their rights to safety and comfort at all times.
- I will treat the staff and facilities of the 4-H camp and University of Nevada, Reno with the highest level of respect and courtesy.
- I realize that while at camp, I am under the supervision of my chapter advisor, under the authority of my school and the state bears no liability for my welfare. I realize I should arrive to the camp under the supervision of my instructor and school district.
- I realize that appropriate conduct is expected from FFA members at all times. Obscene language, roughhousing, or throwing objects will not be tolerated at any time.
- I will not smoke, gamble, use any illegal drugs, or drink alcoholic beverages at any FFA activity.

I realize that as an FFA member, if I am found to be in violation of any of the above rules, I will be subject to disciplinary action. Any disciplinary action will be determined by the State staff and Chapter Advisor. *I fully understand that an infraction of any of these rules may be just cause for being immediately sent home and barred from any further participation at camp.*

### Photo/Video/Publicity Release Consent

Without expectation of compensation or other remuneration, now or in the future, I hereby give my consent to Nevada FFA its affiliates and agents, to use my / my underage child's image and likeness and/or any interview statements in its publications, advertising or other media activities (including the internet). This consent for the Nevada FFA Association State Leadership Camp includes, but is not limited to:

- (a) Permission to interview, film, photograph, tape, or otherwise make a video reproduction of me / my child and/or record me / my child's voice;
- (b) Permission to use my / my child's name; and
- (c) Permission to use quotes from the interview(s) (or excerpts of such quotes), the film, photograph(s), tape(s) or reproduction(s) of me / my child, and/or recording of my / my child's voice, in part or in whole, in its publications, in newspapers, magazines and other print media, on television, radio and electronic media (including the Internet) and/or in mailings for education and awareness.

This consent is given in perpetuity, and does not require prior approval by me.

### Waiver of Liability

We, as indicated by our signatures below, agree to waive the liability of Nevada FFA, Nevada 4-H camp and University of Nevada, Reno and associated staff, from accident or illness occurring while participating in any and all functions during the camp.
